

BMD Community Assistance Program Sponsorship Agreement

This Sponsorship Agreement ("**Agreement**") comprised of this Agreement together with the Schedule is made and entered into on the _____ day of _____ ("**Effective Date**") by and between:

1. _____ ("**the Recipient**"), and;
2. BMD Group ("**the Sponsor**")

The Sponsor has agreed to provide financial support to the Recipient subject to the terms and conditions laid out in this agreement.

PAYMENT

1. Subject to the provisions of this agreement the Sponsor agrees to pay a Sponsorship Fee ("**the Fee**") to the Recipient in the amount set out in Item 1 of the Schedule.
2. The Sponsor shall, subject to receiving appropriate invoices, pay to the Recipient the Fee when the same falls due for payment in the sum and manner set out in Item 2 of the Schedule.

BENEFITS

3. In consideration of the agreement by the Sponsor to pay the Recipient the Fee, the Recipient agrees to provide the benefits set out Item 3 of the Schedule ("**the Benefits**").

PERIOD

4. This Agreement shall be deemed to have commenced on the Effective Date and shall continue until the date listed in Item 4 of the Schedule ("**the Sponsorship Period**").

IMAGES

5. The Sponsor consents to the use of its branding and images solely for the purposes of the Recipient providing the Benefits to the Sponsor, during the Sponsorship Period. The use of the branding and images must be in accordance with the Brand and Communication Style Guide to be provided by the Sponsor to the Recipient.
6. All materials containing the Sponsor's branding and images are to be approved by the Sponsor prior to production or use.
7. Any other use of the images and branding that is not in accordance with clause 5 above shall only be with the express written permission of the Sponsor.

PROMOTION

8. The Recipient consents to the organisation and its spokespeople participating in targeted promotional activities including media, social media, videography and photography for use by BMD at their discretion.

AQUITTAL REPORT

9. The Recipient agrees to complete the BMD Community Assistance Program - acquittal report within 60 days of spending the Fee. The acquittal report shall be returned via email to community@bmd.com.au.

ENTIRE AGREEMENT

10. This Agreement represents the entire agreement between the parties in relation to the subject matter of this Agreement and supersedes any previous agreement, whether written or oral, between the parties in relation to that subject matter.
